The recovery coach (RC) is not a:	You are moving beyond the boundaries of the recovery coach role if you:
Sponsor (or equivalent)	 Perform AA/NA or other mutual-aid group service work in your RC role Guide someone through the steps or principles of a particular recovery program
Therapist/counselor	 Diagnose Provide counseling or refer to your support activities as "counseling" or "therapy" Focus on problems/"issues"/trauma as opposed to recovery solutions
Nurse/Physician	 Suggest or express disagreement with medical diagnoses (including psychiatric diagnoses) Offer medical advice Make statements about prescribed drugs beyond the boundaries of your training and experience
Priest/Clergy	 Promote a particular religion/church Interpret religious doctrine Offer absolution or forgiveness (other than harm done specifically to you Provide pastoral counseling
